General Information:

1. A \$100.00 non-refundable registration fee per family is due with the application form.
2. A deposit of 10% of the annual tuition for the upcoming school year is due with the school contract. **This is non-refundable** and must be paid by within 30 days from receipt of your acceptance letter.
3. The Maryland Immunization Certification, Health Inventory Form, and Emergency Card Form must be completed and on file.
4. Monthly tuition payments are due on the first week of each month beginning in Aug.
5. A child may not begin school without financial clearance (payment of the deposit and 1st month payment) and completion of all necessary forms.
6. Delinquent payments may result in the child's enrollment being suspended.
7. All classes require a minimum enrollment. If enrollment is not met, you will be contacted.

Our preschool seeks to meet the needs of all children who attend our school, and as a general policy, each student will be evaluated, on an individual basis, to determine if Temple Beth Shalom is the right fit for your child. In the case of a child with special needs, consultation with the parents, other relevant professionals, and the Director must take place prior to class placement. Any reasonable modifications to our policies and practices to accommodate a child with special needs will be considered, as long as no fundamental alteration to our existing program occurs. As with any matriculating student, all evaluations are determined on an individual basis, with our primary goal of meeting the needs of each student being paramount.
